

SUMMARY ANNUAL REPORT

This is a summary of the annual report of the IRONROAD WELFARE BENEFIT PLAN, EIN 84-3886755, Plan No. 506, for period 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

IRONROAD INC. dba IRONROAD has committed itself to pay certain self-funded Medical, and Dental claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with UNITED OF OMAHA LIFE INSURANCE COMPANY and EYEMED VISION CARE ON BEHALF OF FIDELITY SECURITY LIFE INSURANCE CO. to pay Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Critical Illness, and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$751,020.
